



# Public debt 2Q2013


Quarterly newsletter

- 1. At the end of the second quarter of 2013 consolidated **public debt** (according to domestic methodology) stood at PLN 888,107.3 million. Compared with the first quarter of 2013 debt increased by PLN 18,170.9 million (2.1%). Since the end of 2012 debt increased by PLN 47,630.5 million (5.7%).\*
- 2. Change of public debt in the first half of 2013 resulted mainly from financing the state budget deficit (PLN 26.0 bn after 6 months of 2013) and currency exchange rate differences (this factor increased public debt by about PLN 13.3 bn).
- 3. At the end of the second quarter of 2013 unconsolidated public debt stood at PLN 947,898.4 million. Compared with the first quarter of 2013 debt increased by PLN 25,371.0 million (2.8%).
- 4. At the end of the second quarter of 2013 **general government debt** (EDP debt, part of the government finance Maastricht criterion) was at **PLN 937,444.4 million**. Compared with the first quarter of 2013 EDP debt increased by PLN 19,684.1 million (2.1%). Since the end of 2012 EDP debt increased by PLN 50,668.3 million (5,7%).
- 5. Similarly to public debt measured according to domestic methodology, the change in EDP debt in the first half of 2013 was mainly influenced by financing the state budget deficit.
- 6. Table 1 presents the differences between public debt according to domestic methodology and general government debt.




#### **EDP** debt



## Public debt, EDP debt and State Treasury debt to GDP ratios (eop)




EDP debt to GDP ratio by European Union Member State






Debt to GDP ratio in Poland, European Union and euro area (eop)


### Public debt by sub-sector:

#### consolidated




The central government is by far the most important debt issuer, representing 92.4% of public debt, of which 92.2% represents State Treasury debt. The local government sub-sector contribution was 7.5% of the total debt, of which 7.1%represents debt of local government units and their unions.

# unconsolidated




The central government and State Treasury made up 89.3% and 89.1% of the total unconsolidated public debt respectively. Unconsolidated social security funds debt includes loans granted by State Treasury (PLN 29.3 bn at the end of the second quarter of 2013), hence larger contribiution of SSF to unconsolidated public debt.

# Consolidated public debt by sub-sector



Social security funds debt plays a minor role in the general government debt with its contribution of 0.1% of the total debt, compared to 2.4% at the end of 2001. The ratio of local government debt to total debt increased between 2008 and second quarter of 2013 by 2.8 pp.


# Changes in consolidated public debt by sub-sector




Changes in public debt by sub-sector since the beginning of 2013 was the result of:

- central government debt increase by PLN 49.8 bn (6.5%),
- local government debt decrease by PLN 1.2 bn (1.8%),
- social security funds debt decrease by PLN 0.9 bn (41.2%).

## Public debt according to the place of issue criterion




At the end of the second quarter of 2013 domestic debt stood at PLN 616.1 bn, up by PLN 39.7 bn (6.9%) compared with the end of 2012. Foreign debt stood at PLN 272.0 bn, up by PLN 7.9 bn (3.0%).




The share of foreign debt in the total public debt accounted for 30.6% at the end of the second quarter of 2013, down compared with 31.4% at the end of 2012.

## Public debt by holder



In the first half of 2013 debt towards domestic banking sector increased by PLN 23.2 bn (15.3%), debt towards domestic non-banking sector increased by PLN 6.0 bn (2.5%) and debt towards foreign inwestors (non-residents) increased by PLN 18.4 bn (4.1%).



At the end of the second quarter of 2013 the share of non-residents in public debt accounted for 52.2% (PLN 463.9 bn).
